SALE REGULATIONS

- A maximum number of 48 lots will be offered.
- The sale will be conducted as an auction.
- COST OF ENTRIES is \$150 (including GST) per pony. All entry fees must be paid for when submitted. Cheques to be made payable to Welsh Pony & Cob Society of Australia Inc.
- Entry fee (\$150 per pony) includes stabling fee for Friday & Saturday night, Transfer cost with the WP&CSA Inc and advertising and promotion of the event.
- No commission will be charged on sales.
- Withdrawals must be accompanied by a Veterinary Certificate. Substitutes will be accepted up to 10 days prior to the Sale date.
- At Sales conducted by the Society, the WP&CSof A Inc reserves the right to refuse future entries from Vendors who, without good reason, have failed to fulfil the obligation to present all lots accepted for Sale.
- A penalty of \$200 and debarment from future Society run Sales will be levied on those in breach.
- This penalty also applies for sales made privately on the Sale premises, and not notified to the Sales Secretary/Office.
- Registration Forms with the transfer section signed must accompany the Entry Forms. Do not date the transfer form.
- A quality photograph for advertising purposes may be submitted with the entry form - this is optional.
- HEIGHT: On youngstock, height should read, 'should make ...'
- No animal over 15 years of age is allowed to be entered.
- Animals must be presented for Sale in show condition. **The 'Best Presented' Sale pony will WIN 12 months membership of the WP&CS of Australia Inc.**
- All ponies/cobs presented for Sale must be drug free.
- Broodmares to be sold 'in foal' - entry must be accompanied by a veterinary certificate of pregnancy and a signed service certificate.
- Foals under 5 months of age must be accompanied by their dam to the sale.
- All animals must be led or ridden whilst in the Sale Ring.
- GST: If the vendor is registered for GST, the GST will be added to the sale price.
- ALL LOTS must be paid for before removal from the Sale premises. Failure to settle within one hour of the end of the day's sale will render the sale void.
- The vendor is expected to ensure that animal/s entered by them receive due care and attention until those animal/s leave the grounds.
