CONDITIONS OF ENTRY - Foundation Stock

Failure to forward all requirements may incur a penalty fee. (Reg 14A)

- The Breeder must attach a Service Certificate to this application if the Stallion is not owned/leased. Where the Breeder owns/leases the stallion at the time of service, the Breeder's Declaration at the bottom of this form must be completed & signed. (Reg 11)
- The breeder is the recorded or legal owner or lessee of the dam at the time of foaling. (Reg 2A)
- The Breeder must sign the application unless previously registered. (Reg 3)
- Applications must be received prior to 31st July in the year of foaling or a penalty fee will apply. (Reg 5B & 25A)
- A filly which qualifies as FS, FS1 or FS2 must be entered and inspected in accordance with the regulations (Reg 24 & 25)
- A filly is not eligible for inspection until she has reached the required height and not before attaining 9 months of age. (Reg 25C)
- Transfer of Ownership may be made at time of application, providing:- (Reg 20)
 - The Breeder and/or registered owner have signed this application & Date of Transfer / /
 - Transfer Fee is paid.
- Applications will **NOT** be accepted unless accompanied by the appropriate fee/s. (Reg 3B)

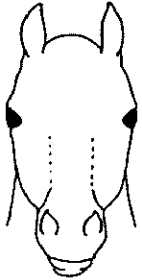

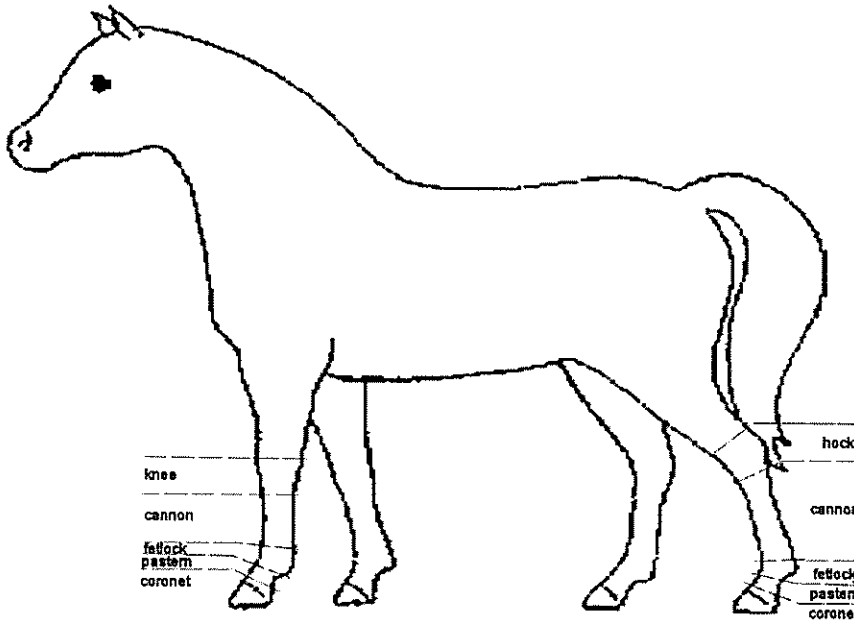

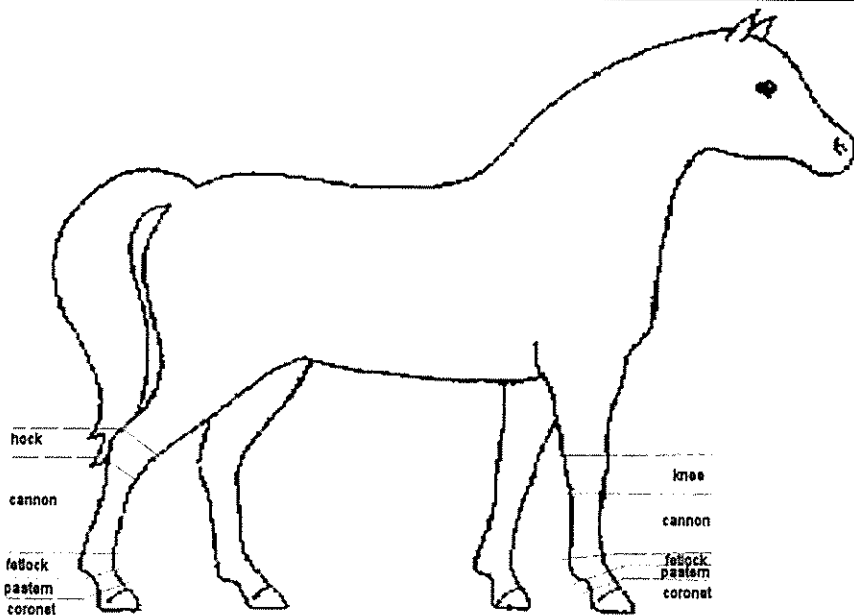
